BOARD CHAIR REPORT





The past year has been about growth, transition and the power of local love to build resilient communities.

In October, we welcomed our new CEO Mark Breslauer, who brings a heart for community and a head for business strategy to the role. He hit the ground running and already his considerable expertise and passion have provided invaluable leadership and concrete results.

I want to thank Danella Parks and Janet Tudor, who in addition to their regular roles as Director of Community Impact and Director of Operations respectively, took on additional responsibilities as interim co-CEOs for several months, leading the organization with skill and dedication during the transition period to our new CEO.

In 2019, our United Way national movement celebrates 100 years of building a strong and inclusive social profit sector in Canada. The first United Ways served as a community's social safety net, pooling resources for the common good. Our local United Way, formed by caring citizens in 1937 to tackle the social challenges caused by the Great Depression, continues to be fuelled by the core values of helping people in need and community self-reliance. Last year alone, generous Victorians donated \$4.7 Million and United Way helped fund over 100 programs to support over 80,000 vulnerable individuals when and where they needed it most. We, like United Ways across the country, are committed to making social issues such as mental health, homelessness, social isolation and poverty #UNIGNORABLE and are seeking sustainable solutions through the power of collective action.

In every generation, United Way has risen to the challenge of tackling the most pressing social issues of the day. Today, one of our newest signature initiatives in Greater Victoria is working with community partners to seek a holistic solution to our region's overdose and opioid crisis.

Recently, our Board rolled up its sleeves in strategic visioning sessions to imagine the best possible United Way of the future. Looking ahead as we forge new partnerships and transform, as we always have, to remain at the forefront of community resilience, local love and local impact will always be at the heart of our mission to improve lives and build community in Greater Victoria.

YOUR LOCAL LOVE IN ACTION HELPED PEOPLE LIKE KEN AND ROSE



As a single dad, Ken experienced some tough times until a United Way-funded food program helped him. "The recession hit and I was laid off. At the end of the month I would think: 'I've paid the babysitting costs. I've paid the rent. Now how do I feed and clothe these kids?' I didn't have any money for groceries. I never understood what the phrase 'the working poor' meant until being placed in that situation." Once things turned around for Ken, he remembered the United Way red logo and felt the need to give back. Donations come off his pay cheque on a weekly basis.



Rose had a difficult childhood; she was diagnosed with depression and anxiety. Now she aspires to be the first Indigenous prime minister and she's on the right path thanks to a United Way program. "In grade nine, I started attending a United Way-funded tutoring and mentoring program after school, and the support I had there made such a big difference. I feel like if I can change one life or inspire one student, then maybe they can inspire ten more."
