A Caring Community Benefits Everyone

Do you know that United Way actually leads the way in social change by addressing root causes of problems facing individuals, families and neighbourhoods? We work closely with our community partners to prevent issues from becoming crisis situations.

United Way funds over 100 programs that help "All that kids can be, From poverty to possibility and Strong communities." Can you imagine what lives would be like if these programs did not exist?

Ways to Give

Gifts by cheque, Visa, or MasterCard may be made at any time, including donations in memory or in honour of loved ones or special friends. Donation receipts are issued upon receipt of your gift. You can structure your gift in installments if you prefer.

Publicly Traded Securities given directly to the United Way allow you to avoid the related capital gains tax.

Endowed Funds allow you to provide a steady and dependable source of income to United Way. We will work with you to establish the parameters in one or more of our impact areas to tailor your endowment to meet your philanthropic needs. You and others can add to the fund during your lifetime and beyond to leave your community a sustaining legacy. In addition, your endowment can be held in perpetuity or for a defined period of time.

Life insurance provides a way to make a gift to the United Way without affecting your estate. A policy can be paid for with regular payments, or you can change the ownership of an existing policy. Tax receipts are issued when United Way is named as beneficiary for either paid-up policies, or for premiums paid annually. The size of your donation exceeds your contribution.
